Dues Structure and Minimums

Household with Two or More Adults: Approximately 1.8% of gross household income. Please pledge based on or above your expected income for 2025-2026.

Household with One Adult: Approximately 0.9% of gross household income. Please pledge based on or above your expected income for 2025-2026

Associate (available to households who are Regular Members in good standing of another congregation): Approximately 0.9% of gross household income. Please pledge based on or above your expected income for 2025-2026.

Building Fund

The membership approved a new building fund in 2023, initially for three years, to pay for needed repairs to the synagogue building. Your building fund contribution is an additional 50% of your regular dues, spread over three years. This can also be calculated as an additional 16.7% per year.

Religious School

Membership is required to enroll in TBE-W School. Tuition is \$275/student. This amount does not include B'nei Mitzvah tutoring, which will be billed separately.

When you pay online by credit card, a small transaction fee is added, so Temple Beth El of Williamsburg fully benefits from your donation. There is no fee for EFT.
